Doctor of Philosophy (Business, Management and Entrepreneurship)

(N/340/8/0735) (10/26) (MQA/PA12958)

The Doctor of Philosophy, PhD (Business, Management & Entrepreneurship) is designed to prepare candidates for a career as an academic or researcher in the public and private sector. The research in the PhD programme is individually supervised; providing an opportunity for students to conduct an in-depth investigation of specific research issues related to business, management and entrepreneurship which contributes to knowledge in that field of study. Application for admission may be submitted throughout the year and for intakes in January or July or at such other time as may be approved for candidates to commence their studies. The application must be accompanied by a preliminary proposal of a minimum of 2,000 words, for assessment on the preparedness and the potential scholarship of the student. It also allows ELMGS to identify an appropriate supervisor for the research study. The preliminary proposal should include the title, an introduction of what the research is about, the purpose and questions that the research seeks to address. It should also include the significance of the study, an outline of the literature that you will be reviewing, a description of the research approach and the time frame for the study.

Application and Intake	Application may be submitted throughout the year for commencement with the January or July intakes or at such time as approved by ELMGS.
Course Duration	Full-time: minimum of 3 years and maximum of 5 years Part-time: minimum of 4 years and maximum of 8 years 2 semesters per year

Please note that the interview serves as the most important entry requirement in determining the goodness-of-fit between the applicants and this programme. Applicants with strong academic qualification may still be rejected if they fail the interview session

The aim of this programme is to provide learners with a comprehensive coursework cum research study. Learners will develop a deep understanding of both subject specialisation and research in one of the three disciplines, i.e. i. Educational Management, ii. Early Childhood Education, and iii. Teaching of English as a Second Language (TESL).

As this programme is conducted on a mixed-mode basis, the first part of the programme focuses on direct instruction to facilitate the mastery of research skills and subject specialisation skills necessary to progress to the next phase of study which is the research dissertation component. With the advantage of content-mastery and research, learners will be prepared to become professional researchers cum subject-matter specialists. The expertise to be gained from this programme can be applied in a variety of job-placements such as universities, colleges, education departments, schools or any institutions offering education programmes.

During the coursework phase, learners will undergo face-toface teaching and learning interactions with facilitators and fellow learners. The coursework phase culminates with the preparation of the Concept Paper which serves as a bridge between theory and practice and prepares learners with appropriate competencies for the next phase of the study programme – the dissertation phase.
